The Ferro GmbH is liable to the Hazardous Incident Ordinance and corresponds to an operation of the lower class (formerly: basic duties).

The operating area as been signaled to the authority Regierungspräsidium Darmstadt, Abteilung Arbeitsschutz und Umwelt Frankfurt, Dezernat 43.2 (Immissionsschutz, Chemie West, Chemikalien), Gutleutstrasse 114, 60327 Frankfurt am Main acc. to § 7 of the 12. Bundesimmissionsschutzverordnung (12. BImSchV – Hazardous Incident Ordinance) on October 4, 2017.

3. Comprehensive explanation of the activities in the operating area

Manufacturing of ceramic materials. Manufacturing of ceramic colors and decoration materials via grinding and mixing processes.

4. Description of the relevant hazardous materials as well as their main hazardous characteristics

The materials used, which are relevant for hazardous incidents, are liable to the following hazardous incident classification:

- 1.3 E environmentally hazardous
- 1.3.1 E1 hazardous to aquatic environment, category acute 1 or chronic 1
- 1.3.2 E2 hazardous to aquatic environment, category chronic 2

5. General information, how the public concerned is informed in case of a hazardous incident: adequate information, how to react in case of a hazardous incident and how to get this information electronically.

As soon as the fire detection system registers a fire, the professional Frankfurt Fire Department, Feuerwache 2, is alarmed.

Generally the Regierungspräsidium Darmstadt is also informed in case of such an incident.

In case of an incident, please listen to the speaker announcements of police and fire fighters as well as possible radio or TV announcements.

6. Date of the last on-site inspection and how to get this information electronically

The last on-site inspection (authority inspection) of the operating are was held by the authorities on June 10 and July 13, 2016.

Next date: 2022 (acc. to inspection program Hessen of December 31, 2017)
